The Patient Protection and Affordable Care Act, commonly referred to as the Affordable Care Act (the “ACA”), has been in effect since October, 2010. However, its most far-reaching and controversial provisions – a series of mandates that require almost everyone to be covered by a health plan – do not begin until January 1, 2014. Every individual and business will be impacted by those mandates in one manner or another. The impact on you will depend on your “status” (employee, retiree, small business owner, large business owner, etc.) and the actions that you, or your business, decide to implement this year.
